


Corporation or Limited Liability Company Certificate of Authorization Application



Use this form to apply for a Certificate of Authorization if you offer engineering or surveying services and are a Corporation or Limited Liability Company (LLC).

23204 - APPLICATIONS

You do not need to apply if you are a Professional Corporation, Professional Service Corporation, or Professional Limited Liability Company.

Your application must include:

- A Designated Engineer/Land Surveyor Affidavit (page 3 of this application)
- A Corporate/LLC Resolution naming the designated engineer, land surveyor, or both (page 4 of this application)
