Purpose of the proposal and its anticipated effects, including any changes in existing rules: Minor housekeeping changes were made to the existing language to help clarify requirements to take the fundamentals of land surveying examination. Existing language was amended to allow individuals to get certified as a land surveyor-in-training regardless of where they took the NCEES FLS examination, as long as requirements are met.

Reasons supporting proposal: Changing the certification language allows individuals that took and passed the NCEES Fundamentals-of-Land-Surveying (FLS) examination in other states the opportunity to get LSIT certification in Washington, if requirements are met.
